2. I am aware that completing at least 50 hours of service accords only an eligibility to register in Phase 2B but does **not** guarantee a place for my child in the school.
3. Parent Volunteers will still be subjected to balloting should the number of applicants be greater than vacancies during Phase 2B registration.
4. I am aware that successful enrolment of my child into the school does not secure my child a place with the school transport or student care service.
5. Successful applicants are required, in addition to other contributions, to attend the annual PSG AGM (hours cannot be clocked in for this event).
6. Successful applicants are required to contribute on a regular basis. If missing in action for more than 3 months, the parent volunteer would be required to leave the Parent Support Group and lose the eligibility status.
